

**NYSW600BC 51st ANNUAL TOURNAMENT RULES USBC CERTIFIED**

1. Entrants must hold membership as follows:
  - a. Current USBC card (purchase associate membership or pay a participation fee of \$5.00) & current NYS USBC membership.
  - b. Current NYSW 600 Bowling Club card (membership may be obtained at time of entry).
2. Entry fee shall be \$25 (prize fee \$12.50, expense/bowling fee \$12.50). **NO REFUND OF ENTRY FEE. Return check fee \$20.**
3. Entrants shall bowl **THREE** games across six lanes and may participate only once.
4. The tournament will be conducted in five divisions, according to average:
 

OPEN DIVISION	DIVISION A	DIVISION B	DIVISION C	DIVISION D
185 & higher	175 to 184 incl.	165 to 174 incl.	155 to 164 incl.	154 and lower
5. Average requirements as follows:
  - a. Highest USBC certified league average as of the end of the previous season, minimum of 21 games. Summer certified league averages may be used provided no winter season average is available and it meets the 21 game minimum requirements.
  - b. Bowlers who do not have a previous season or summer average shall use their highest certified league average as of **APRIL 30, 2018** with a minimum of 21 games or bowl in Open Division.
  - c. Rule 319a-2 & 319e (regarding current season average being 10 pins or more higher than previous season's average) WILL NOT APPLY.
  - d. Tournament Manager will verify all averages through BOWL.com and will change any incorrect average.
6. Rule 319d (regarding reporting of prize winnings) WILL NOT APPLY.
7. Substitutes will be permitted to bowl before the start of the first game provided they meet the requirements of the tournament rules.
8. In the case of a tie for first place, in any and all divisions, co-champions will be declared and duplicate awards will be presented. Cash prizes for all ties will be equally divided. Prize Ratio 1-5. Prize money returned 100% in each division.
9. Any rule not covered will be decided by the Tournament Chairman.
10. Entrants who wish to bowl together must send their entries together. **NO DATE CONFIRMATION WILL BE SENT. YOU WILL BE NOTIFIED**

**IF YOUR FIRST CHOICE IS NOT AVAILABLE. Bowlers must report one hour prior to scheduled squad time.**

11. All entries postmarked the first Post Office business day following the entry closing date shall be accepted. **ENTRIES CLOSE 4/30/2018**
