NYSW600BC 47TH ANNUAL REGION 7 TOURNAMENT RULES (USBC CERTIFIED)

1. Entrants must hold membership as follows:
 - a. Current USBC card (purchase an associate membership or pay participation fee of \$5.00)
 - b. Current NYSW600BC card (membership may be obtained at time of entry)
2. Entry fee shall be \$15.00 (prize fund \$12.50 expense \$2.50). **Bank and handling fee of \$30 charged for all returned checks.**
3. Entrants shall bowl three games during league play and submit their highest 3 game total bowled during the dates 11/21/20 thru 12/19/20.
4. The tournament will be conducted in five (5) divisions, according to average

5. Average requirements as follows:
 - a. Highest USBC certified league average as of the end of the previous season, minimum 21 games. Summer certified league averages may be used provided no winter season average is available and it meets the 21 game minimum requirement.
 - b. Bowlers who do not have a previous season average shall use their certified league average as of the closing date of the entry, minimum 12 games or bowl in the OPEN Division.
 - c. USBC Rule 319a-2 and 319e (regarding current season average being 10 pins or more higher than the previous season's average) and Rule 319d (regarding reporting of prize winnings.) WILL NOT APPLY.
 - d. Where average records are published by the local association, the book average will be recognized as official, providing the average book lists the highest average of all certified leagues, including mixed leagues, regardless of whether bowled as a regular member or substitute. **All averages will be verified from Bowl.com**
 - e. Failure to use proper average shall disqualify the score if submitted average is lower than actual average.
6. In case of a tie for first place, in any and all divisions, co-champions will be declared and duplicate awards will be presented. Cash prizes for all ties will be equally divided. Prize ratio is 1-5. Prize money returned 100% in each division.
7. Any rule not covered will be decided by the Tournament Director.
8. All entries postmarked the first Post Office business day following the entry closing date shall be accepted. Entries received after that will be returned. **ENTRIES CLOSE: 11/14/2020**
9. Submit completed entry form with check or money order payable to: **NYSW600BC REGION 7**
10. The 1st & 2nd place winners in each division will be eligible to compete for the NYS600 Regional Championship upon entry into the NYSW600BC 53rd Championship tournament in SCHENECTADY, N.Y.
11. Upon completion of bowling, submit score verification form with recap sheet no later than 12/23/2020 to the Tournament Director via mail, email or text. Info on verification form.
